NOTICE OF ANNUAL GENERAL MEETING

NOTICE IS HEREBY GIVEN that the 2022 AGM of Harbin Electric Company Limited (the "Company") will be held at Conference Room of the Company located at 1399 Chuanxiyi Road, Songbei District, Harbin, Heilongjiang Province of the PRC on Thursday, 25 May 2023 at 9:00 a.m. to consider and, if thought fit, pass the following resolutions. Unless the context requires otherwise, capitalised terms used hereinafter shall have the same meanings as those defined therein in the circular dated 24 April 2023 issued by the Company (the "Circular").

ORDINARY RESOLUTIONS

1. To consider and approve the Directors' Report of the Company for the year ended 31 December 2022;
2. To consider and approve the Report of the Board of Supervisors of the Company for the year ended 31 December 2022;
3. To consider and approve the audit accounts and the auditor's report of the Company for the period from 1 January 2022 to 31 December 2022;
4. To declare the 2022 final dividend of RMB0.006 per share (tax included) of the Company to be paid on 25 July 2023;
5. To appoint Da Hua Certified Public Accountants (Special General Partnership) as auditor of the Company for the 2023 financial statements of the Company and authorize the Board of Directors of the Company to fix its remuneration;
6. To reelect Mr. Zhang Yijia as an executive Director of the Company without director remuneration.

SPECIAL RESOLUTIONS

7. To ratify the Board of the Company the authority to appoint a proxy to fill a casual vacancy of the Board or as an additional Director, his/her term of office shall expire at the conclusion of the next AGM of the Company;
8. To authorize the Board of the Company to carry out the offer purchase or repurchase by trades of H shares of not more than 10% of the total issued H shares of the Company at the date of passing this resolution through The Stock Exchange of Hong Kong Limited as deemed appropriate. The validity of the authorization is 12 months from the date of passing such resolution or until the conclusion of the first AGM after passing such resolution or its revocation or alteration through a special resolution at a general meeting, whichever is the earliest;
9. Conditional upon the above resolution to purchase shares being passed and implemented, the Board of the Company shall be authorized to take necessary amendments to clause 16 and clause 17 of the Articles of Association of the Company, so as to reflect the alterations to the Company's share capital structure and restrict capital arising from the purchase of shares.

Persons buying shares of the Company during book closure shall not be entitled to attend and vote at the AGM. In order to be qualified for attendance at the AGM, all duly completed transfers of shares to be done with the relevant share certificates must be lodged with Hong Kong Registrars Limited, the Company's share registrar in Hong Kong, at Shops 1712–1716, 17th Floor, Hopewell Centre 183 Queen's Road East, Wanchai, Hong Kong (for the holders of the H Shares only) or the Company's principal place of business in the PRC at 1399 Chua Xi Yi Road, Sobai District, Harbin, Heilongjiang Province of the PRC (for the holders of the Domestic Shares only) not later than 4:30 p.m. on Friday, 19 May 2023.
2. For the purpose of determining Shareholders' entitlement to the 2022 final dividend, the register of members of the Company will be closed from Monday, 19 June 2023 to Friday, 23 June 2023 (both days inclusive), during which period no transfer of shares will be registered. Shareholders whose names appear on the register of members as at Monday, 19 June 2023 are qualified for the 2022 final dividend which will be paid on Tuesday, 25 July 2023. In order to be qualified for the 2022 final dividend, all duly completed transfer documents to be done with the relevant share certificates must be lodged with Hong Kong Registrars Limited, the Company's share registrar in Hong Kong, at Shops 1712–1716, 17th Floor, Hopewell Centre 183 Queen's Road East, Wanchai, Hong Kong (for the holders of the H Shares only) or the Company's principal place of business in the PRC at 1399 Chua Xi Yi Road, Sobai District, Harbin, Heilongjiang Province of the PRC (for the holders of the Domestic Shares only) not later than 4:30 p.m. on Friday, 16 June 2023.
3. Any Shareholder entitled to attend and vote at the AGM is entitled to appoint one or more persons (whether a Shareholder or not) as his/his proxy to attend and vote on his/his behalf.

To be valid, the form of proxy, to be done with a notarially certified power of attorney or other document of authority, if any, under which the form is signed, must be returned to the Company's share registrar in Hong Kong, Hong Kong Registrars Limited at 17M Floor, Hopewell Centre 183 Queen's Road East, Wanchai, Hong Kong (for the holders of the H Shares only) or the Company's principal place of business in the PRC at 1399 Chua Xi Yi Road, Sobai District, Harbin, Heilongjiang Province of the PRC (for the holders of the Domestic Shares only) as soon as possible but in any event not less than 24 hours before the time fixed for holding the AGM or a adjournment thereof.
5. Completion and return of the proxy form will not preclude Shareholders from attending and voting in person at the AGM. In such cases the proxy form will be deemed to be revoked.
